Board recessed to executive session at 7:31 a.m., pursuant to Texas Government Code Sections 551.071, 551.072 and 551.074 for the following purpose(s):

- Consultation with attorney regarding pending or contemplated litigation. Pursuant to Texas Open Meetings Act, Section 551.071. Discuss potential 2023 litigation to be filed by the District on PID 2857463, 2581255, 2705540.
- 2 Deliberation regarding real property. Pursuant to Texas Open Meetings Act, Section 551.072.

Board reconvened to open session at 7:44 a.m.

Motion by Brian Mantzey to accept reports and approve action items contained in consent agenda. Seconded by Carson Underwood. Motion carried.

- **D.** Action taken: Board approved minutes from May 25, 2023 regular meeting.
- **E.** Action taken: Board reviewed the May 2023 bills.
- **F.** Action taken: Board reviewed and accepted the May 2023 financial reports.
- **G.** Action taken: There were no checks needing to be signed by Chairman, Gary Rodenbaugh.
- **H.** Action taken: Board reviewed and accepted the May 2023 report of checks and electronic transfers greater than \$25,000.

- The Board voted to approve the final draft of the 2024 Proposed Budget as presented in the Public Hearing. Brian Mantzey motioned to adopt the 2024 Budget by Resolution # 2023-79, in the total amount of \$29,794,600. Ron Carlisle seconded the motion. Motion carried.
- Proposed Plan Comparison for plan year 2024. After discussing the projected valuation results, the Board voted to adopt by resolution an elected contribution rate of 13.25%. Carson Underwood made the motion to adopt Resolution # 2023-1121 for the 2024 employer contribution rate for the Texas County District Retirement System (TCDRS). Ron Carlisle seconded the motion. Motion carried.
- K. Mr. Wright addressed the Board with his recommendation for the Board not to grant a retiree COLA for budget year 2024, based on the guidelines found in Policy 1007. Brian Mantzey motioned to accept the chief appraiser's recommendation. Carson Underwood seconded the motion. Motion carried.
- L. The Board received Mr. Wright's recommendation to make a lumpsum payment in the amount of \$400,000 to the Texas County District Retirement System (TCDRS) in the fourth quarter to offset future COLA costs and Unfunded Actuarial Accrued Liability (UAAL). Motion to approve chief appraiser's recommendation was made by Brian Mantzey, and seconded by Carson Underwood. Motion carried.
- M. The Board received Mr. Wright's recommendation for the designation of budget reserve funds below the line, based on the year-end 2022 audit. Brian Mantzey motioned to adopt Resolution # 2023-1123 designating budget reserve funds below the line as outlined. Carson Underwood seconded the motion. Motion carried.
- N. The Board received the chief appraiser's recommendation and voted to adopt a Resolution under 41.12 of the Property Tax Code, allowing the Appraisal Review Board to approve the Appraisal Records with 10% of protests not determined. Motion made by Carson Underwood and seconded by Ron Carlisle. Motion carried.

- Carson Underwood motioned to receive Mr. Wright's recommendation and authorize the chief appraiser to file 2023 litigation on the following: PID 2857463, PID 2581255, and PID 2705540. Ron Carlisle seconded the motion. Motion carried.
- P. Brain Swanson, Deputy Chief Appraiser of Business Operations and Compliance, addressed the board regarding the District's depository. Mr. Tim Pinon, of Valley View Consulting, L.L.C., was present to provide the Board with the proposal analysis conducted by Valley View Consulting L.L.C. Carson Underwood made a motion to adopt Resolution # 2023-1125, designating Independent Financial to serve as the District's depository for a two-year term, from September 1, 2023 to August 31, 2025, with an option to extend the contract for one two-year term under the same terms and conditions upon signing of a final depository agreement between parties. Ron Carlisle seconded the motion. Motion carried.
- Q. Carson Underwood motioned for the Board to approve the District's recommendation and to authorize the chief appraiser to enter into a contract with Valley View Consulting for Investment Advisory services. Ron Carlisle seconded the motion. Motion carried.

R. Reports

- 1 Chris Nickell, Taxpayer Liaison Officer, presented the TLO Monthly Status Report. Two confidential complaints were received. Because the complaints were confidential there was no ability to follow up. Mr. Nickell presented Customer Service Survey updates, and an update regarding HB 1285 which was signed and will take effect January 1, 2024.
- Mr. Nickel addressed the Board with the Monthly TDLR Status Report. On May 25, 2023, the chief appraiser received a TDLR complaint from a taxpayer filed on January 9, 2023. Mr. Nickell provided an overview of the investigation into the complaint. The details of the investigation were submitted to TDLR on June 6, 2023 as the District's response to the complaint.
- 3 Mr. Swanson presented an update on the 2022 SDPVS.

Notes:

The taxpayer left before an appraiser was notified. No additional notes were listed on the account.

Had the appraiser spoken to the property owner, they would have informed him that the value was adjusted to \$606,600 and his ARB hearing back on 9/15/2022 was dismissed as a "no show". We would have instructed him of his options going forward by filing a 25.25(c) (1-4), 25.25 (d) (1) or 41.411 of the property tax code. All these protest options would have required the property owner to establish the merits of the specific protest option before any adjustment of value could be made by the ARB.

- The remaining assessed value of the nearly 14,000 properties under appeal is approximately \$8 billion or 3% of the appraisal roll.

As of the date of this report, we have the following litigation information:

- There have been 50 lawsuits filed at this point for the 2023 tax year. The total certified value of lawsuits received is \$608,199,734. This number will only continue to increase as we are not half way through the filing season.
- We currently have over 66% of the 2022 lawsuits settled, and more than 98% of the other remaining years settled going back to 2019.
